## Dust Control Agreement

In accordance with the RM's dust control policy, the option of dust control application is being extended to ratepayers of the Municipality. The following **terms and conditions must be met in order to qualify to have the dust suppressant applied.**

- Dust control shall not be applied on RM road allowances by individuals, special requests shall be directed to your Division Councillor and prior approval may be required.
- **An indemnity agreement (below) must be signed prior to receiving dust control.**
- *Sites treated may become rough or may develop potholes so if a road reaches a state where the condition of the driving surface poses a danger to the traveling public, the RM may add gravel or grade the road which may render the dust control ineffective.* The ratepayer will be responsible for the full cost of the application that is non-refundable.
- The location where the dust suppressant is to be applied the measuring and staking will be done in consultation with the RM employees.
- If it is determined by the municipality that the road requested is not in condition to sustain dust control application, no dust control will be applied.
- 1<sup>st</sup> round application is anticipated early spring (weather and contractor availability dependent) and a possible second application will be determined at Council's discretion.
- The cost calculation is based on length and width and how many litres put on each site plus \$100.00 water fee plus GST.
- *It is important to note that road widths may vary, the same application rate/length/width ratio is applied and there may be overlap in the centre. Please ensure the 200m distance measurements are confirmed with the municipality and any special requests or circumstances must be in writing below which may require pre-approval. Your invoice will reflect actual litres applied to your site.*
