BYLAW NO. 9-2022

A BYLAW TO NAME ROADWAYS WITHIN THE RURAL MUNICIPALITY OF WEYBURN NO. 67

The council of the Rural Municipality of Weyburn No. 67 in the Province of Saskatchewan enacts as follows:

1. That the Rural Municipality of Weyburn No. 67 that the names of certain roadways within Rural Municipality as identified below shall be changed in the following manner:
 - a. The portion of Township Road 082 Highway 35 East up to West side of Highway 39; Land Descriptions ORA 28-08-14-2 Ext 0, ORA 17-08-14-2 Ext 0, ORA 19-08-14 W2 Ext 0, St/L 1-Plan 66R36289 Ext 1 Plan Number 66R36289 shall be named "22nd Avenue SE";
 - b. That Land Description SW 11-08-14-2 Plan 75R22929 Ext 1 Plan Number 75R22929, Land Description NW 02-08-14-2 Plan 75R22929 Ext 1 Plan Number 75R22929, Land Description St/L 3-Plan 96R03692 Ext 0 Plan Number 96R03692 and St/L 1-Plan 96R03692 Ext 0 Plan Number 96R03692 shall be named "Golf Course Road";
 - c. That Land Description ORA 112-07 13 2 Ext 112 As Described on Certificate of Title SK174281137, Land Description ORA 117-07-13-2 Ext 0, Land Description ORA 133-07-13-2 Ext 0, Land Description ORA 136-07-13-2 Ext 0, and Land Description ORA 51-07-13-2 Ext 0 shall be named "Nickle Lake Road";
 - d. That Land Description Blk/Par S1-Plan 102109429 Ext 0 Plan Number 102109429 shall be named "Fellner Road";
 - e. That Land Description Blk/Par S2-Plan 102109429 Ext 0 Plan Number 102109429 shall be named "Cossette Lane";
 - f. That Land Description Blk/Par S3-Plan 102109429 Ext 0 Plan Number 102109429 shall be named "Courtlin Road";
 - g. That Land Description Blk/Par S4-Plan 101997625 Ext 0 Plan Number 101997625, Blk/Par S5-Plan 101997625 Ext 0 Plan Number 101997625, Blk/Par B-Plan 101971762 Ext 0 Plan Number 101971762, and Blk/par S6-Plan 101997625 Ext 0 Plan Number 101997625 shall be named "Metheral Way";
 - h. That Land Description ORA 2-09-14-2 Ext 0 shall be named "Goranson Place";
 - i. That Land Description St/L 2-Plan BO2047 Ext 0 Plan Number BO2047 and St/L 11-Plan BO2047 Ext 0 Plan Number BO2047 shall be named "King Street";
2. Unless otherwise stated the names shall remain unchanged unless by an amending bylaw.
