A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT RESPECTING THE SHARING OF MUNICIPAL OFFICE SPACE AND ADMINISTRATIVE SERVICES.

The Council of the Rural Municipality of Weyburn No. 67 in the Province of Saskatchewan enacts as follows:

- The Rural Municipality of Weyburn No. 67 is hereby authorized to enter into an agreement, attached hereto and forming part of this bylaw, and identified as Exhibit A, with the Rural Municipality of Brokenshell No. 68 for the purposes stated within the agreement.
- 2. The Reeve and Administrator of the Rural Municipality of Weyburn No. 67 are hereby authorized to sign and execute the attached agreement identified as Exhibit A.

AGREEMENT

BETWEEN

The Rural Municipality of Weyburn No. 67, of Weyburn, Saskatchewan

and

The Rural Municipality of Brokenshell No. 68, of Trossachs, Saskatchewan

The aforementioned two municipalities believe that it is advantageous to share a mutual municipal office. Therefore they will enter into an agreement. Following are the terms which form the agreement to allow this arrangement to proceed.

The expenses related to this agreement which will benefit the municipalities will be based on a 65% share for the Rural Municipality of Weyburn No. 67 and 35% share for the Rural Municipality of Brokenshell No. 68. The accounts which will be split on this basis include the following:

Administration Salary Administration Benefits Administration Convention/Travel Office Rent/Maintenance Office Fuel/Water/Power Office Telephone/Postage Stationery/Supplies

Costs associated with initial cost or replacement of office equipment will be shared on a basis of 65% for the R.M. of Weyburn, and 35 % to the R.M. of Brokenshell.

Any other expenses, which, in the opinion of the Councils benefits both municipalities, will also be shared on that basis.

The Rural Municipality of Weyburn will pay all costs associated with the pertinent expenses. An accounting will be given to the Rural Municipality of Brokenshell Council at the end of each month and payment for Brokenshell's share will be made to the R.M. of Weyburn.

The terms of this agreement shall be binding on each party from the date of signing for a one year term, and shall be considered automatically renewed from year to year. Terms of this agreement may be altered at any time by mutual consent. This agreement may be terminated by either party with one years written notice of intent.
